2. Choose "Person" as Name Type
3. Type in Last Name, First Name & Date Of Birth
4. Click on "Find"
5. Leave all other statuses as shown

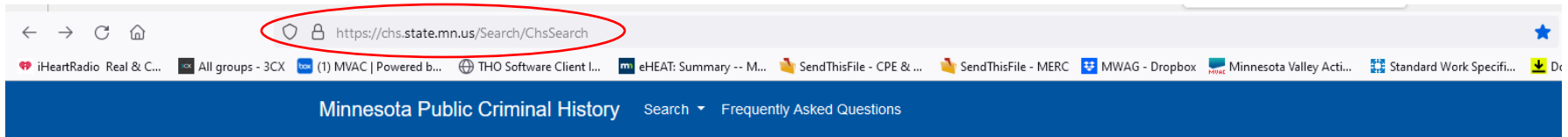
